Pool Codes: New compliance codes require changes to pool skimmers and fence pickets.

1. New skimmers at a cost between \$50 and \$200 each must be installed to comply with the new codes. Leacroft currently has 12 skimmers that must be replaced.
2. New codes require fewer than 4 inch gaps between pickets in the fence surrounding the pool. An estimate for approximately \$1500 was

provided to show the cost of adding these posts to our existing fence. The estimate did not include the cost of repainting the fence to match the new posts. Also, new latches are required to be installed on the gate.

Playground Vandalism:

- Henderson filed an insurance claim for damage done to play equipment. Julie will confirm whether we have a deductible of \$500 or \$1000.
- Cunningham Associates of GameTime play equipment provided a quote of \$7981.38 to replace those parts that had been spray painted. Henderson was advised that the spray paint could not be pressure washed off the plastic play equipment.
